## 1. CALL TO ORDER

Chairman Eric Averett called the meeting to order at 1:00 P.M.

## 5. APPROVAL OF MINUTES

Director Dennis Johnston moved to approve the regular Board Meeting Minutes of January 4, 2018 and Special Board Meeting Minutes of February 23, 2018. Upon second by Director Michael Blaine, a vote was taken with no abstentions and was unanimously carried.

#### 6. TREASURERS REPORT

a. Director Robert Kunde reviewed the accounts payable with the Authority Board. A motion was made by Director Dennis Johnston to pay the open accounts, in the amount of \$544,127.94 and ratify payments made in the amount of \$116,554.40. Upon a second by Director Skye Grass, a vote was taken with no abstentions and was unanimously carried.

## 7. KRWCA MANAGER REPORT/ILRP PROGRAM UPDATE

Manager Bell reported on the following topics:

  - ii. 2018 Membership Enrollment Update:
    - 1. 754 Members
    - 2. 523,000 Irrigated Acres Enrolled
    - 3. 616,000, APN Acres included
  - iii. 2018 Reporting Status:
    - 1. FEs: 656 Required, 92% filed (601), 8% Not filed (55)
    - 2. NMPs: 607 Required, 85% filed (517), .08 Not Started (57), .05% Incomplete (33).

## b. Education and Outreach:

i. Four Reporting Deadline Reminder Emails sent to members as well as reminder letters and personal phone calls.

### c. CVRWQCB:

- i. Compliance and Enforcement Activities: There is some activity with calls, emails and walk-ins, but not as much as in December. Due to the March 1 deadline non-members have been told that we are focused on assisting members with a reporting deadline and will be happy to assist them after March 1.

## 8. KRWCA ORGANIZATIONAL STRUCTURE CONSIDERATION

After each Director provided input from their respective Boards it was determined that no change to the KRWCA entity type or structure is needed at this time. Further discussion determined that amending section 3.01 Governing Body, section 3.02 Officers and section 3.03 Committees of the JPA Agreement would be appropriate. Manager Bell will provide the JPA Agreement to the Board for review and any further suggested edits. Ernest Conant and Manager Bell will revise the JPA Agreement and provide suggested amendments for Board consideration at the next meeting.

### 9. REPORT OF PROVOST & PRITCHARD CONSULTING GROUP

# a. MPEP Update

Mr. Ryan Dodd reported of the following:

- i. Approval of Geisseler N Removal Coefficients
  - Twelve Central Valley water quality coalitions (including Kern County coalitions) contracted with Dr. Daniel Geisseler at UC Davis to develop comprehensive information on N removal as a requirement of the NMP TAWG process.
  - 2. On January 13, 2017, Dr. Geisseler submitted a report/literature review titled: "N concentrations in harvested plant parts A literature overview"
  - 3. This report contains the "best available" N removed estimates in the peer removed and published literature for close to 99% of crop acreage in the Central Valley (show comparison table).
  - 4. KRWCA did not use Geisseler's numbers in the 2016 AMR or NAR because we were working on those reports soon after publication of Geisseler's report and were unsure if the report was approved. However, all other coalitions outside of Kern County did use Geisseler's numbers and will continue to do so, and we stated that we will use the numbers for the 2017 AMR in the 2016 AMR.
  - Although Geisseler's numbers are close to the best available, and the SSJV MPEP Committee already has projects in the works to improve the numbers, which will be an iterative and ongoing process.
  - 6. Mr. Dodd requested formal approval to use Geisseler's numbers, however the Board requested that he first provide the full Geisseler Report one more time for their review prior to making a decision. It was agreed that the item will be included on the April Board agenda for official approval.



## ii. MPEP Workplan

- 1. The SSJV MPEP Committee submitted a revised MPEP work plan on September 28, 2017. No comments or approval have been received yet.
- 2. The Northern MPEP group submitted their revised work plan on February 15, 2018, and it open for public review. Comments are due to the Regional Board by March 29, 2018.

# iii. North and South MPEP Groups Coordination

1. Representatives from the SSJV MPEP Committee have begun attending the Northern MPEP meetings.

### iv. MPEP Status

- 1. Currently diligently working on completing the first SWAT model run for the Central Valley. Much of this work is funded by the CIG.
- Establishing contracts for new projects, including updating N removal information and other irrigation and nutrient management projects.
- 3. Developed three "Priority Practices" fliers: 1) Abandoned wells, 2) wellhead protection, and 3) N in irrigation water calculator.

# v. UCCE NMP Management Field Day

 UCCE and the Almond Board of California are hosting a grower/adviser nutrient management field day on March 21, 2018 in Kern County. It is part of the Almond Board and UC Davis (Patrick Brown) FREP project about nutrient management in almonds. This will hopefully be an option for growers to get CEUs for their ILRP NMP grower self-certification.

## b. GW Trend Monitoring:

Velvet Gaston reported on the following:

- i. Central Valley Groundwater Monitoring Collaborative (CVGMC) Update: Coalitions initiated coordination meetings in response to the Regional Board amendment allowing group workplans, included additional stakeholders (oil & gas, food processors)
  - CVGMC Conceptual Workplan: Phase I: ILRP Technical Work Plan to be completed 180 days after CVGMC Conceptual Workplan approval, Phase II: Coordination Among Existing Groundwater Monitoring Programs, Phase III: Groundwater Monitoring Program coordination with SGMA Groundwater Sustainability Plans (GSPs) and the CV SALTS Surveillance and Monitoring Program under the SNMP

# ii. CVGMC/GTM Timeline

- 1. May 5<sup>th</sup>, 2017 Regional Board approved the option to participate in Regional Groundwater Monitoring Workplans
- July 1<sup>st</sup>, 2017 KRWCA GTM Workplan Submitted to Regional Board
- 3. October 31<sup>st</sup>, 2017 Central Valley Groundwater Monitoring Collaborative (CVGMC) MOA and Conceptual Workplan Submitted with 11 other Coalitions to the Regional Board



- 4. November 17<sup>th</sup>, 2017 CVGMC Conceptual Workplan Approved by the Regional Board

# iii. CVGMC Technical Workplan

- Lead Author: Luhdorff & Scalmanini Consulting Engineers
   Subconsultant: Provost & Pritchard, MLJ-LLC
   KRWCA Budget allocation: ~14.2%, final contract amount not set
- Technical Workplan Components due May 16<sup>th</sup>, 2018
   Monitoring Networks: coalition specific monitoring methodology and well networks, including candidate well selections. Each Coalition is responsible for reviewing & vetting candidate wells. Quality Assurance Program Plan (QAPP): defined analytical methods, sampling schedules, data management and standard operating procedures (SOPs)

Data Management: coordinated data management and processing

Reporting: develop report format and analytical framework for annual monitoring reports

## iv. Well Selection

- 1. KRWCA GTM Proposed Network: 0-3 wells per Township, <u>107</u> total wells to monitor
- 2. Well Construction Information: Well is domestic, shallow agriculture, or monitoring well (no point source), Well depth is <a href="mailto:shallow relative to local groundwater depth">shallow relative to local groundwater depth (sometimes >600 ft)</a>, Well has a sanitary seal at least 20 feet deep, made of cement, concrete, or bentonite
- 3. Well Location Information: Well is at least 100 feet from any septic leaching field or 150 feet from a seepage pit, Well is not adjacent to any point source dischargers (industrial, food processors, WWTPs, dairies, etc.), Well is accessible with a working pump and/or a small enough casing for sampling (rules out many elevation monitoring wells)
- 4. Initial Progress: 32 of 44 Townships have been evaluated, 116 Candidate wells found from initial data review, some townships will require additional research to find sufficient candidates
- 5. Volunteer Well Data: Solicit owners & districts to volunteer wells for monitoring that fit the selection criteria
- Next Steps: May 2016: Request permission to conduct site visits and sampling of candidate wells, Fall 2018: Complete on-site review & survey of all candidate wells. Fall 2018: First sampling event of final, vetted wells



- 7. Caveats: Well details will only be provided to the Regional Board with owner permission, NOT all candidate wells will be vetted on site or surveyed by May 16, but we will try our best, There will be an option to eliminate duplicative monitoring within the Coalition and with adjacent monitoring efforts, will seek to delay/phase deep groundwater monitoring.

- c. <u>SDEAR Proximity Workplan Status Update</u> John Schaap provided an update.
- d. <u>Pesticide Monitoring Proposal</u> Manager Bell reported that the official approved was received January 12, 2018.
- e. <u>Chanac Creek SQMP Resubmission</u> Information Item Velvet Gaston reported the following:
  - i. The KRWCA submitted a revised SQMP and Source ID Study to the Regional Board on November 1, 2016. This SQMP includes DDE, Mo, and algae toxicity. On December 7, 2017, the Regional Board responded with a comment letter that basically stated that the SQMP provided insufficient details and data. A revised SQMP was due by February 9, 2018, but the KRWCA requested an extension to April 6, 2018.
  - ii. Staff met with the RB on February 4, and with the stakeholders on February 22, 2018 to review the RB comments and to develop a plan for the revisions. Ultimately, our strategy for the April 6 resubmittal is to clarify and strengthen parts of the report, and propose a plan for follow-up, including more details on completed SECPs, a description of some of the shifts in management practices, etc.
  - iii. We will seek approval for submission at the April 5, 2018 board meeting.
